PARTITION AGREEMENT

We, the undersigned, are the heirs of Ivy McNeese, deceased, Mark McNeese, deceased, Laura Henderson, deceased, Jim Harvey, deceased, Betty Stewart, deceased, Lena Washful, deceased, and Will Henderson, deceased. We own undivided interests in several tracts of lands in Montgomery County, Washington County, Robertson County and other counties. One tract, in particular, that we own is the old Ivy McNeese Homestead tract in the Lemuel Smith Survey, Abstract 502 in Montgomery County, Texas. We, and each of us desire to partition and to divide all of our inheritance lands.

We each bargain, sell and convey to each other to have and to hold all of these lands, and as follows, in order to perfect this partition.

The North two thirds (2/3) of each and every tract shall hereafter be owned separately, as follows:

- The children of McAllister Matson shall own the northwest one sixth (1/6).

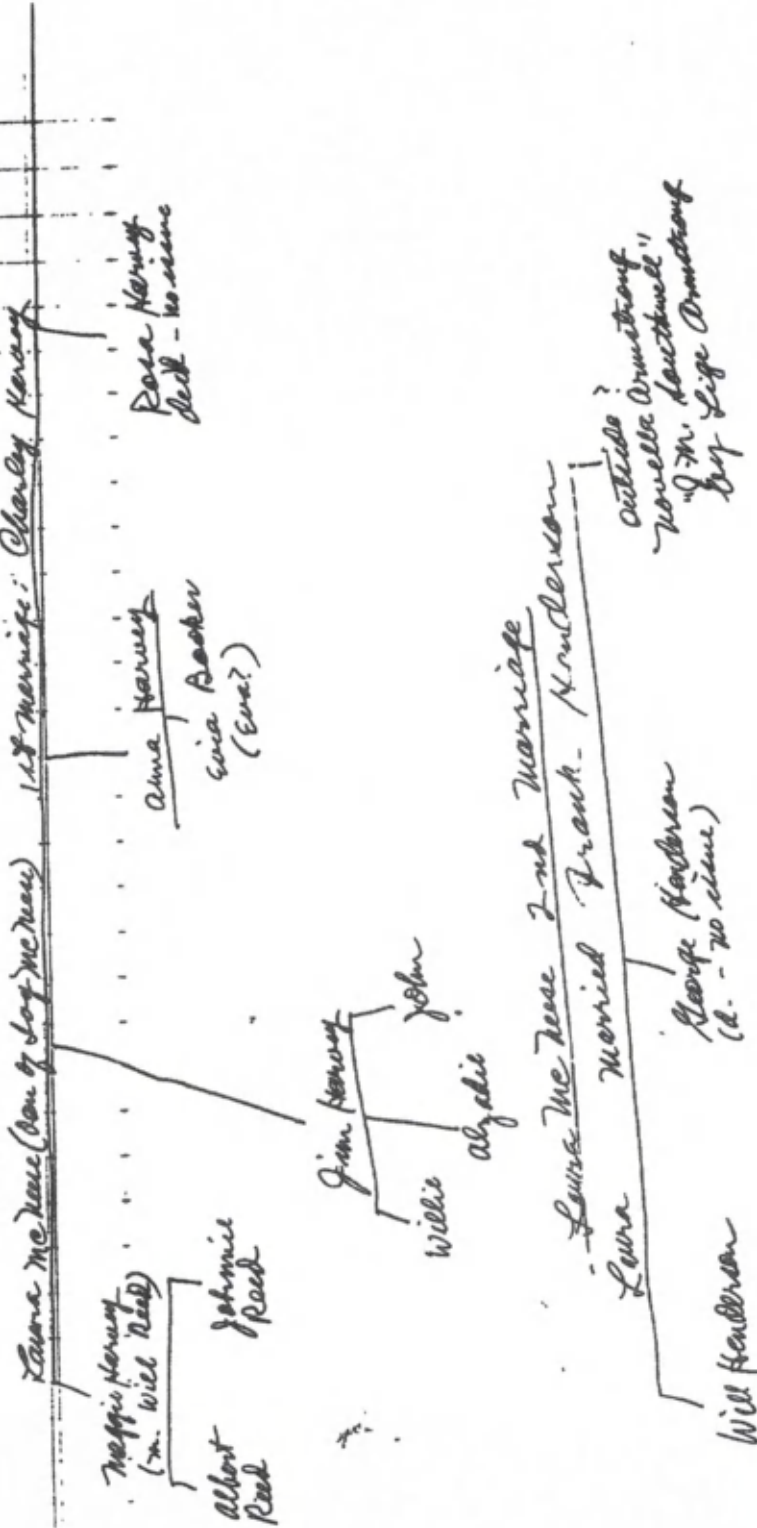
